

Bank of Ireland is closely involved in the mortgage industry's initiative with UK Finance and Which? to make our fees and charges easy for you to understand.

Our tariff of charges fully reflects the initiative's good practice principles. This same document is being used across the industry to help customers compare mortgages.

When looking at the fees that other firms charge, you may notice some that don't appear in our tariff (below). This means we don't charge you these fees.

When will you pay this charge?

Before your first Monthly Payment.

These are the fees and charges you may have to pay before we transfer your mortgage funds.

Name of charge	What this charge is for	How much is this charge?
Lending fee	A fee for making a loan under a new mortgage, due on completion but may be deferred until the mortgage is fully repaid. This fee will be deferred unless you tell us otherwise before completion and interest will not be charged on the fee in the meantime. We will not be entitled to vary the fee if you choose to defer payment.	£195
Funds transfer fee	Electronically transferring the mortgage funds to you or your solicitor.	£15
Legal fee	You will normally instruct a solicitor to act on your behalf in connection with your home purchase transaction. You may be required to pay their legal fees and costs as part of their work on your behalf. These fees/ costs are normally charged by the solicitor, directly to you unless we tell you that we will contribute to the legal costs as part of your product deal.	These fees/costs are charged by the solicitor directly to you
Product fee	This is charged on some mortgages as part of the deal. It can be paid up-front or added to the total mortgage amount. If you add it to your mortgage, you'll pay interest on it at the same rate as the rest of your borrowing. It might be a flat fee, or a percentage of the loan amount.	£0-£2,500
Re-inspection fee	If your mortgage is released in stages and you're using it to renovate your home, this covers the new valuation we need to do after the work's carried out. <i>At Bank of Ireland we may charge this in additional circumstances such as Northern Ireland Self Build cases, or where immediate works are required to the property. We will tell you if you are required to pay a re-inspection fee.</i>	£50

Valuation fee	<p>Valuation and Surveys</p> <p>When you buy a house and need a mortgage, we will commission a mortgage valuation. The mortgage valuation advises us of the value of a property and of any characteristics of the property (including significant defects) which might affect its value as security for the proposed loan. You should not rely on the mortgage valuation when deciding whether to purchase the property or how much you should pay for it. It is not a survey and is for our benefit, rather than yours.</p> <p>If you want a more detailed survey, you'll need to arrange this yourself with a Surveyor. This will provide information on any specific areas you'd like covered and on the condition of the property. You can find more information on local surveyors and the different types of survey on the Royal Institution of Surveyors (RICS) website at https://www.rics.org/uk/</p> <p>Scottish valuations</p> <p>In Scotland, it is a legal requirement that the seller provides potential purchasers with a Home Report. This includes a Mortgage Valuation Report and provides buyers with information regarding the condition and value of a property, ahead of committing to the purchase. When will you pay this charge?

If you change your mortgage.

If you change to a new mortgage product, the 'before your first monthly payment' fees may also apply at this stage.

Revaluation fee	Applicable when you are applying for a Further Loan or if an initial offer of loan for either a main or further loan has expired. All fees include a £25 administration fee. Change of parties administration fee	Our administrative costs of adding or removing someone (a 'party') from the mortgage.	£299
Let With Consent Fee	When you intend to let out your property, but don't have a Buy to Let mortgage, you'll pay a 'Let With Consent' Fee. This is where we agree to you letting out your property under your existing Residential mortgage. You are required to pay this fee annually for as long as the consent to let is in place.	£199 annual fee
Deeds	Production and return of Title Deed documents.	£50
Second charge registration	Charged where we need to register a second charge by another lender.	£15

When will you pay this charge?

Ending your mortgage term.

Name of charge	What this charge is for	How much is this charge?
Early Repayment Charge	You may be charged this if you repay your mortgage in full before the mortgage term ends.	Up to 5% of the loan being repaid
Mortgage release fee	We charge this fee when the mortgage is fully repaid in order to cover our administration costs and external costs such as Land Registry fees. For existing customers, the amount of the fee depends on when your mortgage was offered and whether we have since agreed with you to change any terms and conditions that apply. For new customers, no mortgage release fee is currently payable but your terms and conditions will say that we have the right to impose this fee in future.	Up to £55

When will you pay this charge?

If you are unable to pay your mortgage

These are the most common charges you may have to pay if you fail to keep up with your mortgage payments. Some charges, for example, relating to our repossession of the property, may apply later in the process and will be dependent on your circumstances.

Arrears statement	A statement issued each time your mortgage account falls into arrears.	No fee
Property check/ Reconnection visit	Charged if we need to verify occupancy or condition of the property, or when your case has been referred to a Field Collector to re-engage with us.	£72

Name of charge	What this charge is for	How much is this charge?
Field Collector visit	Charged when your case has been referred to a Field Collector for a home visit.	£108
Reconnect field visit	Charged when no visit is undertaken and refused to discuss and/or engage with us.	£12
Cancelling a Field Collector visit	Payable if you fail to respond to requests from a Field Collector to make an appointment, or you cancel or fail to keep an appointment.	£72
Property repossession	Possession management department administration fee. If it is necessary to repossess your property we will also charge the costs in connection with selling your property as well as insuring it. These costs will vary for each property.	£400
Further legal costs	If we need to take further legal action, the costs of our action, including payments to professional third parties such as Solicitors or Law of Property Act receivers, will be added to your mortgage account.	Case specific
