Can Bank of Ireland UK change the interest rate?	<p>We have the right to change the interest rate on Classic Saver. The reasons we may change your rate are outlined in Clause 10 of the Personal Savings Terms and Conditions provided prior to account opening. These reasons include reflecting changes to the Bank of England Base Rate or market rates, changes due to legal or regulatory developments, or business reasons. You can also find a copy of the Terms and Conditions on our website.</p> <p>If we change your interest rate to your disadvantage, we will give you notice in writing a minimum of 14 days before the change takes effect, as long as you have at least £100 in your account.</p>		
What would the estimated balance be after 12 months based on a £1,000 deposit?	<p>For a deposit of £1,000, the projected balance after 12 months (1.70% interest for 12 months) is £1,017.00.</p>

How do I open and manage my account?	<p><b>Eligibility</b></p> <ul style="list-style-type: none"> <li>▶ Classic Saver is available to personal customers aged 12 and above.</li> <li>▶ Must be resident in the UK or ROI only.</li> <li>▶ Minimum balance to open the account is £1 and this must be maintained.</li> <li>▶ There is no maximum balance limit.</li> </ul> <p><b>Opening and managing your account</b></p> <ul style="list-style-type: none"> <li>▶ You can open your account online.</li> <li>▶ You can manage your account online, in branch, by phone or in writing to us.</li> <li>▶ If your account is not funded within 30 days, we may close your account.</li> <li>▶ An account opened for a minor age 12 to 16 needs parental consent. Proof of identify and address will be required for both the child and the parent.</li> </ul> <p>If you wish to switch in to or out of this account, please ask in a Bank of Ireland UK branch.</p>		
Can I withdraw money?	<p>Classic Saver offers you the ability to make withdrawals.</p> <ul style="list-style-type: none"> <li>▶ All withdrawals should be against cleared balances.</li> <li>▶ Withdrawals are free of charge.</li> <li>▶ No notice period or penalties for withdrawals.</li> </ul> <p>You can move money to/from your account using any of the following methods:</p> <ul style="list-style-type: none"> <li>▶ At any Bank of Ireland UK branch.</li> <li>▶ By telephone or using our banking app or 365 online.</li> </ul>		
Additional Information	<p>Interest is paid gross.</p> <p>You can cancel the account within 14 days of opening and your money will be returned in full with interest.</p>
